Eligibility & Seedings

- All events are open to age is 40 and over Participants.
- Team Seeding in the draws is based on SEPT 2018 TTCAN's ratings (if the players are ranked in the TTCAN's system) available at the time of the draw

Format

- Each Team is consisted of 2 players and shall have preliminary round robin of 3 best of 5 games to 11 points followed by single knockout. The order of play is A vs X, B vs Y, Doubles AB vs XY, A vs Y, B vs X. Team match ends if one team first registered 3 wins.
- Events with less than 3 entries may be cancelled or combined with another event on discretion of the tournament committee.

Rules

- Current ITTF Laws of Table Tennis will be in effect.
- All rackets must be one side black and one side red with ITTF approved coverings.
- Tie-breaks in round-robins will be decided by score of matches, games, points, only of those players involved in the tie.
- Only shorts and T-shirts are allowed to be worn during matches unless consent is given by the tournament referees. **Colour of playing shirt should not be white.**
- **Non-marking shoes must be worn in gym and street shoes are not allowed.**
- Players need to bring their own rackets and practice balls.

Umpiring

In general, players will be required to umpire their own matches. Umpires will be provided for semi-finals & finals.
